## **1. History**

Organization was formed and registered under society registration act 1860 on 5th December 2005 with dedicated youth having the zeal to work for the down trodden people of Jharkhand. Dream of Founder - "To work for the downtrodden people strengthening and to enhance their economical situation". Organizational team felt to transform dream of founder and secretary into reality.

The team decided to work for ST, PTG, SC, OBC, marginalized groups, farmer, artisan of all 24 districts of Jharkhand. The thrust areas of organizational intervention was decided by the team was NRM, Agriculture & allied activities, Income generation/ Livelihood ,Health, Environment, Skill development-Training & Capacity Building, Hand holding & Building community Institutions, Information Communication and Education and Behavioral Change Communication and Sports for the development of downtrodden people .

Journey of development started through awareness generation among deprived community through Nukad Natak, street play on witchcraft, child marriage, dowry, child labour issues, malaria, kalajar, hiv-aids, wash, education, agriculture, environment and forest issues.

Promotion of sports by the organization in the rural areas gave the opportunity to the rural youth to participate in cricket and football tournament at panchyat, block, district and state level. Presently many rural youth are playing with district and state level team.

As the year passed coordinated team effort under the leadership of secretary, professional team and volunteer were recognized by government funding agencies. The first funding was supported by Jharkhand AIDS Control Society for MSM project at Chiabasa in the year 2009-10.

Presently organization presence is in all district of Jharkhand. Awareness generation activity is ongoing throughout the year in all district of Jharkhand .The organization project funding operational district are Pakur, Latehar, Simdega,West SinghBhum and Ranchi. In the year 2015-16 development funding support are from NRLM-JSLPS, JTDS, NABARD, Department Of Rural Development, JSWM-IWMP Neisbud, Ministry Of Small & Micro Enterprises, Department Of Industry-Jharcraft, Department Of Panchayati Raj Institutions, JSACS, SAATHII-Project Pehchan, Unicef, Cini, world Vision, CSR Of KGVK , CSR Of Jindal Steel.The total population of downtrodden people benefitted directly are 50000 household and indirectly 10 lacs.

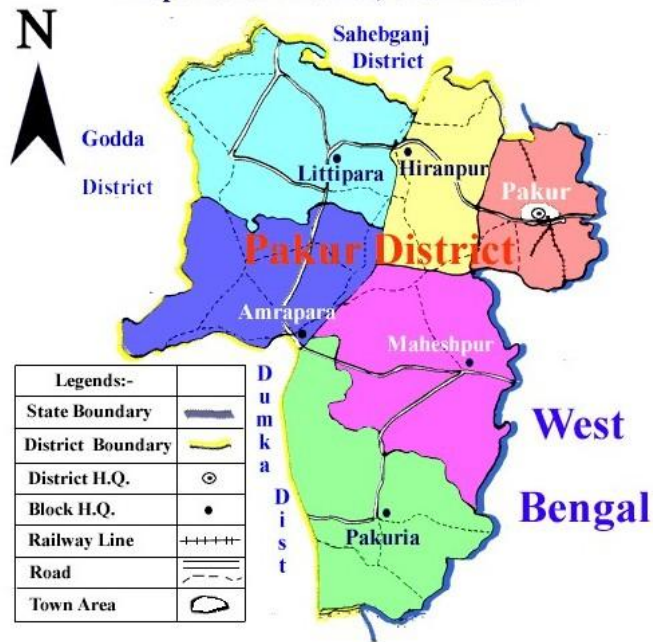

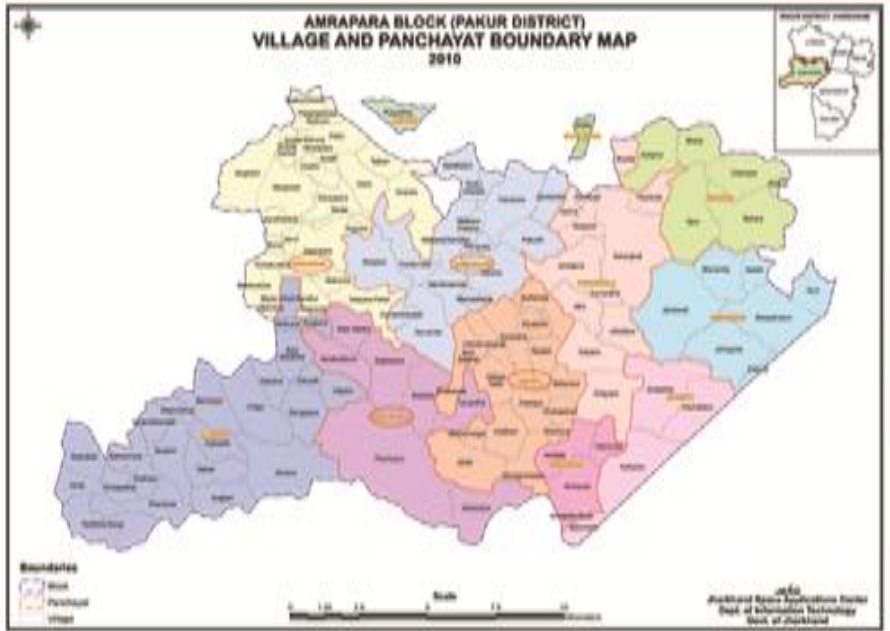

### **5.3 JHARKHAND BIODIVERSITY BOARD, LATEHAR DISTRICT – PEOPLE’S BIODIVERSITY REGISTER (PBR) & BIO DIVERSITY MANAGEMENT COMMITTEE (BMCs)**

With the Collaboration and support with Jharkhand Biodiversity Board, Our Organization is designing and forming PBR at Panchayat, Block and District Level. We are also forming BMC at Block and District Level.

The People’s Biodiversity Register is a document of people’s knowledge of biodiversity, intended to protect people’s rights to their intellectual property and natural resources.

Its objective is to build an open and transparent information system on biodiversity resource from village level upwards. The register can be used to promote the sustainable management of biodiversity resources. Moreover, claims of communities and individuals to knowledge about biodiversity resources and their uses can be supported.

As per the Biological Diversity Act, 2002 (section 41), every local body shall constitute a Biodiversity Management Committee (BMC) within its area of jurisdiction.

These BMCs have been constituted for the purpose of promoting conservation, sustainable use and documentation of biological diversity including preservation of habitats, conservation of land races, folk varieties and cultivars, domesticated stocks and breeds of animals and microorganisms and chronicling of knowledge related to biological diversity.

The main function of the BMC is to prepare People’s Biodiversity Register in consultation with the local people. The Register shall contain comprehensive information on the availability and knowledge of local biological resources, their medicinal or any other use or any other traditional knowledge associated with them.

## 5.4 TARGETED INTERVENTION PROGRAM, CHAIBASA DISTRICT

With the Collaboration and support with Jharkhand State AIDS Control Society (JSACS), Our Organization is running Targeted Intervention Program (TI) in the Chaibasa District since the year 2011-12. Presently we are working on the two wing i.e. Men who have Sex with Men (MSMs) and Female Sex Worker (FSWs). The target population of MSMs and FSWs are 350 and 350 respectively.

It is estimated that more than 90% of HIV transmission in India is related to unprotected sexual intercourse or sharing of injecting equipment between an infected and an uninfected individual. Not everyone in the population has the same risk of acquiring or transmitting HIV. Much of the HIV transmission in India

occurs within groups or networks of individuals who have higher levels of risk due to a higher number

of sexual partners or the sharing of injection drug equipment.

These **core high risk groups** (HRGs) of individuals who are most at risk include:

- Female sex workers (FSWs)
- High risk men who have sex with men (MSM), and transgenders (TGs)
- Injecting drug users (IDUs)

**Note: In Volume I, HRGs refers only to CORE HRGs (FSWs, MSM/TGs, IDUs), and not to truckers/migrants.**

The broader transmission of HIV beyond these HRGs often occurs through their sexual partners, who also have lower risk sexual partners in the “general” population. For example, a client of a sex worker might also have a wife or other partner who is at risk of acquiring HIV from her higher risk partner.

Individuals who have sexual partners in the highest risk groups and other partners are called a “bridge population”, because they form a transmission bridge from the HRG to the general population. This is shows how HRG members or HRGs have many sexual partnerships with different bridge population members, who in turn have at least one partner in the general population. Given this pattern of epidemic transmission, it is most effective and efficient to target prevention towards HRG members to keep their HIV prevalence as low as possible, and to reduce transmission from them to the bridge population.

## **1. History**

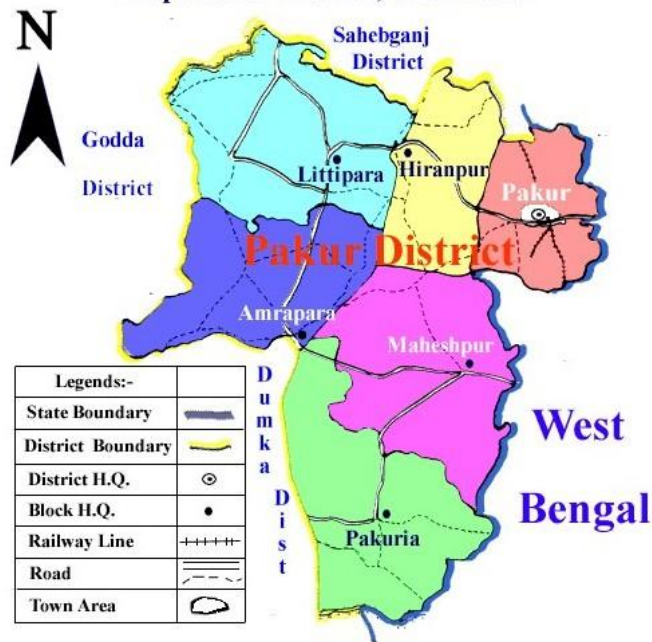

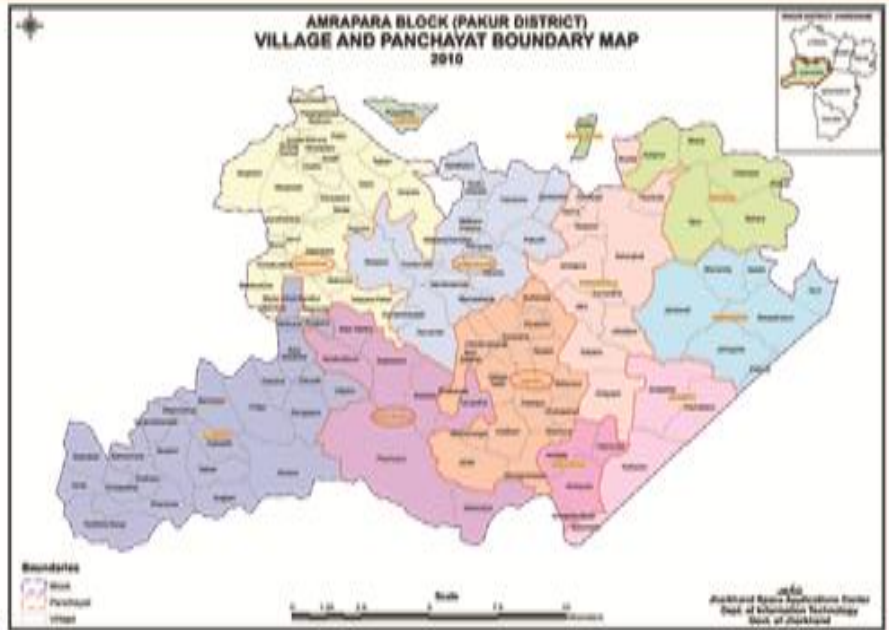

### **5.3 JHARKHAND BIODIVERSITY BOARD, LATEHAR DISTRICT – PEOPLE’S BIODIVERSITY REGISTER (PBR) & BIO DIVERSITY MANAGEMENT COMMITTEE (BMCs)**

With the Collaboration and support with Jharkhand Biodiversity Board, Our Organization is designing and forming PBR at Panchayat, Block and District Level. We are also forming BMC at Block and District Level.

The People’s Biodiversity Register is a document of people’s knowledge of biodiversity, intended to protect people’s rights to their intellectual property and natural resources.

Its objective is to build an open and transparent information system on biodiversity resource from village level upwards. The register can be used to promote the sustainable management of biodiversity resources. Moreover, claims of communities and individuals to knowledge about biodiversity resources and their uses can be supported.

As per the Biological Diversity Act, 2002 (section 41), every local body shall constitute a Biodiversity Management Committee (BMC) within its area of jurisdiction.

These BMCs have been constituted for the purpose of promoting conservation, sustainable use and documentation of biological diversity including preservation of habitats, conservation of land races, folk varieties and cultivars, domesticated stocks and breeds of animals and microorganisms and chronicling of knowledge related to biological diversity.

The main function of the BMC is to prepare People’s Biodiversity Register in consultation with the local people. The Register shall contain comprehensive information on the availability and knowledge of local biological resources, their medicinal or any other use or any other traditional knowledge associated with them.

## 5.4 TARGETED INTERVENTION PROGRAM, CHAIBASA DISTRICT

With the Collaboration and support with Jharkhand State AIDS Constrol Society (JSACS), Our Organization is running Targeted Intervention Program (TI) in the Chaibasa District since the year 2011-12. Presently we are working on the two wing i.e. Men who have Sex with Men (MSMs) and Female Sex Worker (FSWs). The target population of MSMs and FSWs are 350 and 350 respectively.

It is estimated that more than 90% of HIV transmission in India is related to unprotected sexual intercourse or sharing of injecting equipment between an infected and an uninfected individual. Not everyone in the population has the same risk of acquiring or transmitting HIV. Much of the HIV transmission in India

occurs within groups or networks of individuals who have higher levels of risk due to a higher number

of sexual partners or the sharing of injection drug equipment.

These **core high risk groups** (HRGs) of individuals who are most at risk include:

- Female sex workers (FSWs)
- High risk men who have sex with men (MSM), and transgenders (TGs)
- Injecting drug users (IDUs)

**Note: In Volume I, HRGs refers only to CORE HRGs (FSWs, MSM/TGs, IDUs), and not to truckers/migrants.**

The broader transmission of HIV beyond these HRGs often occurs through their sexual partners, who also have lower risk sexual partners in the “general” population. For example, a client of a sex worker might also have a wife or other partner who is at risk of acquiring HIV from her higher risk partner.

Individuals who have sexual partners in the highest risk groups and other partners are called a “bridge population”, because they form a transmission bridge from the HRG to the general population. This is shows how HRG members or HRGs have many sexual partnerships with different bridge population members, who in turn have at least one partner in the general population. Given this pattern of epidemic transmission, it is most effective and efficient to target prevention towards HRG members to keep their HIV prevalence as low as possible, and to reduce transmission from them to the bridge population.

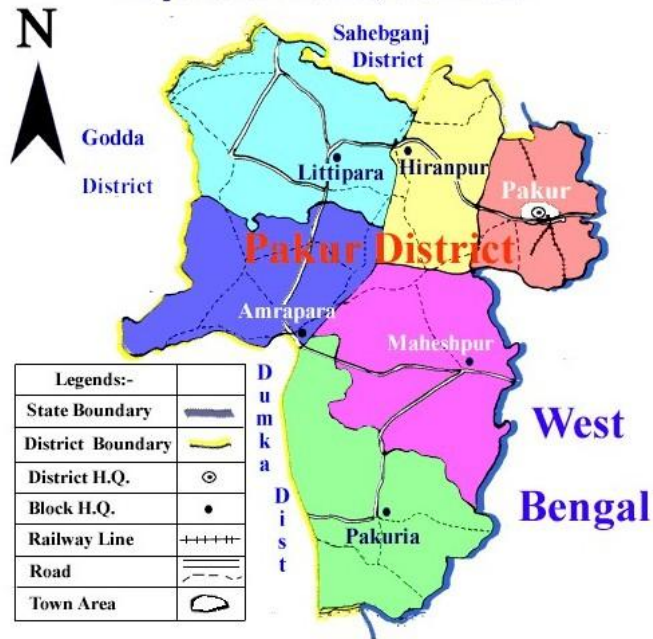

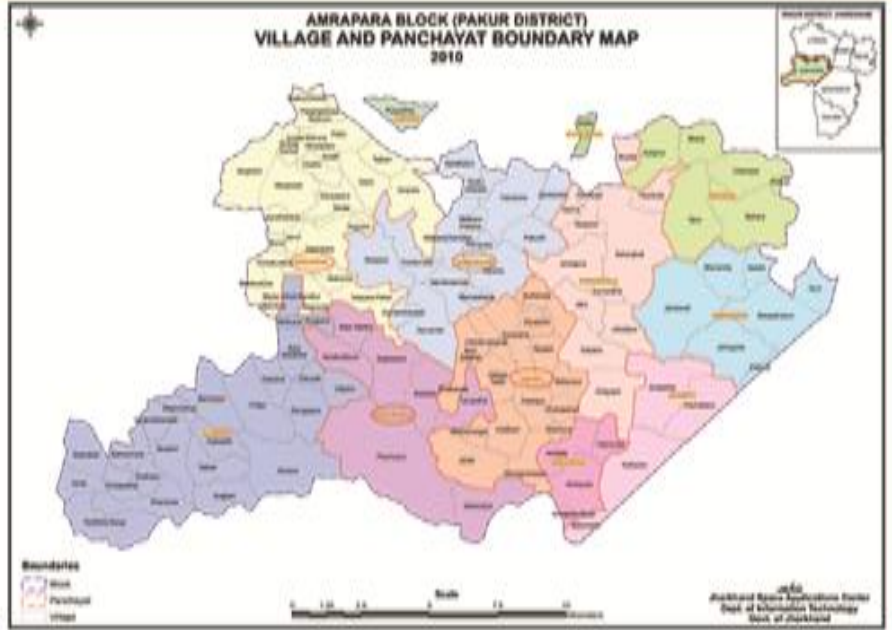

### **5.3 JHARKHAND BIODIVERSITY BOARD, LATEHAR DISTRICT - PEOPLE'S BIODIVERSITY REGISTER (PBR) & BIO DIVERSITY MANAGEMENT COMMITTEE (BMCs)**

With the Collaboration and support with Jharkhand Biodiversity Board, Our Organization is designing and forming PBR at Panchayat, Block and District Level. We are also forming BMC at Block and District Level.

The People's Biodiversity Register is a document of people's knowledge of biodiversity, intended to protect people's rights to their intellectual property and natural resources.

Its objective is to build an open and transparent information system on biodiversity resource from village level upwards. The register can be used to promote the sustainable management of biodiversity resources. Moreover, claims of communities and individuals to knowledge about biodiversity resources and their uses can be supported.

As per the Biological Diversity Act, 2002 (section 41), every local body shall constitute a Biodiversity Management Committee (BMC) within its area of jurisdiction.

These BMCs have been constituted for the purpose of promoting conservation, sustainable use and documentation of biological diversity including preservation of habitats, conservation of land races, folk varieties and cultivars, domesticated stocks and breeds of animals and microorganisms and chronicling of knowledge related to biological diversity.

The main function of the BMC is to prepare People's Biodiversity Register in consultation with the local people. The Register shall contain comprehensive information on the availability and knowledge of local biological resources, their medicinal or any other use or any other traditional knowledge associated with them.

## 5.4 TARGETED INTERVENTION PROGRAM, CHAIBASA DISTRICT

With the Collaboration and support with Jharkhand State AIDS Control Society (JSACS), Our Organization is running Targeted Intervention Program (TI) in the Chaibasa District since the year 2011-12. Presently we are working on the two wing i.e. Men who have Sex with Men (MSMs) and Female Sex Worker (FSWs). The target population of MSMs and FSWs are 350 and 350 respectively.

It is estimated that more than 90% of HIV transmission in India is related to unprotected sexual intercourse or sharing of injecting equipment between an infected and an uninfected individual. Not everyone in the population has the same risk of acquiring or transmitting HIV. Much of the HIV transmission in India

occurs within groups or networks of individuals who have higher levels of risk due to a higher number

of sexual partners or the sharing of injection drug equipment.

These **core high risk groups** (HRGs) of individuals who are most at risk include:

- Female sex workers (FSWs)
- High risk men who have sex with men (MSM), and transgenders (TGs)
- Injecting drug users (IDUs)

**Note: In Volume I, HRGs refers only to CORE HRGs (FSWs, MSM/TGs, IDUs), and not to truckers/migrants.**

The broader transmission of HIV beyond these HRGs often occurs through their sexual partners, who also have lower risk sexual partners in the “general” population. For example, a client of a sex worker might also have a wife or other partner who is at risk of acquiring HIV from her higher risk partner.

Individuals who have sexual partners in the highest risk groups and other partners are called a “bridge population”, because they form a transmission bridge from the HRG to the general population. This is shows how HRG members or HRGs have many sexual partnerships with different bridge population members, who in turn have at least one partner in the general population. Given this pattern of epidemic transmission, it is most effective and efficient to target prevention towards HRG members to keep their HIV prevalence as low as possible, and to reduce transmission from them to the bridge population.
